If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer. 3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU / Public Listed Company for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have guoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total QUANTITY. The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023 OM_No.1_4_2021_PPD_dated_18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of

quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

7. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 30% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

8. Reverse Auction would be conducted amongst first 50% of the technically qualified bidders arranged in the order of prices from lowest to highest. Number of sellers eligible for participating in RA would be rounded off to next higher integer value if number of technically qualified bidders is odd (e.g. if 7 bids are technically qualified, then RA will be conducted amongst L-1 to L-4). In case number of technically qualified bidders are 2 or 3, RA will be between all without any elimination. If Buyer has chosen to split the bid amongst N sellers, then minimum N sellers would be taken to RA round. 7. Warranty

Bidder / OEM has to give an undertaking that after expiry of warranty period, it will provide Comprehensive Maintenance Service for next 5 years for the offered products at the rate not more than 5 % of contract price per annum. Buyer reserves the right to enter into a CMC agreement with the Successful Bidder / OEM after expiry of the Warranty period at above mentioned rate and the payment for the CMC charges would be made Biannually after rendering of the CMC Services of the relevant CMC period. 12. Generic

1. The Seller shall not assign the Contract in whole or part without obtaining the prior written consent of buyer.

2. The Seller shall not sub-contract the Contract in whole or part to any entity without obtaining the prior written consent of buyer.

3. The Seller shall, notwithstanding the consent and assignment/sub-contract, remain jointly and severally liable and responsible to buyer together with the assignee/ sub-contractor, for and in respect of the due performance of the Contract and the Sellers obligations there under.

13. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

14. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

- **A.** Bidders are advised to quote prices as per technical specification and additi onal specifications mentioned below. However detailed breakup of quoted pr ices should be provided in Price Format A and uploaded in the prescribed p lace (Financial Document Required) on online GeM portal. The prices quoted in the prescribed field on GeM portal will be considered for ranking purpose.
- **B.** Total price quoted in Price Format A must match with the price quoted in GeM portal.
- **C.** The Bidders are advised to quote price of Spare parts, Consumables in the attached Format B and C accordingly and uploaded the same in the prescri bed place (Financial Document Required) on online GeM portal. The equipm ent should be supported with spares for a minimum period of 10 years after successful installation and commissioning." All the spares and consumables required for the equipment should be made available through GeM througho ut the agreed supporting period".
- **D.** The three years warranty sought for is **OEM free warranty** without any a dditional cost towards extended warranty to fulfil the tender condition. The charges, if any, claimed by the bidder towards warranty in this regard and in

cluded in the product cost in Price Format -A should be mentioned in the pri ce format D also. This warranty charges shall not be considered for calculati ng actual CAMC value to be payable after warranty period. Where the total c ost does not include such warranty charges, the bidder shall submit a declar ation- "Certify that the Equipment/accessories quoted in the bid is having O EM free warranty of three years and the total cost quoted in the bid does not include any warranty charges to fulfil the tender condition of three year warr anty". This declaration shall be furnished along with the Technical bid in For mat-G. False declaration may lead to rejection of bid. Proforma invoice from the OEM (Foreign principal company) indicating the nature of after sale servi ce including warranty condition shall be furnished along with the technical bi d.

- Ε. As per the Institutes general policy, the maximum CAMC charges after war ranty period shall be 5% of the cost of the equipment. However, the bidders can guote CAMC charges in the range of 3 to 10 % of the cost of equipment, depending on the nature of equipment to be maintained. The CAMC charges shall be guoted in percentage rate in GeM bid and escalation in CAMC charg es shall be allowed at maximum 5% of the CAMC charges after every three y ears of CAMC. This CAMC charges at Net Present Value shall be taken into a ccount for arriving the lowest responsive bidder. The cost of the equipment for CAMC calculation shall be manda torily furnished in format D.
- **F.** The successful bidder shall enter into CAMC/AMC as chosen by SCTIMST, 3 (three) months prior to the completion of warranty period. The CAMC/AMC will commence after the date of expiry of warranty period from the date spe cified in the work order and agreement executed in this regard, which will b e treated as the first year of CAMC/AMC.
- **G.** Liquidated Damages :
 - 1. If the supplier fails to deliver or install/commission any or all of the good s or fails to perform the services within the time frame(s) incorporated in the Purchase Order, the Purchaser shall, without prejudice to other rights and remedies available to the Purchaser under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, co

mmissioning and/or services until actual delivery or performance subject to a maximum of 10% of the contract price. Once the maximum is reache d Purchaser may consider termination of the contract.

If any delay by the supplier in maintaining its contractual obligations toward s delivery of goods and performance of services shall render the supplier lia ble to any or all of the following sanctions:

- a. Imposition of liquidated damages,
- b. Forfeiture of its Performance Security and
- c. Termination of the Contract for default

2. Supplier should ensure uninterrupted service delivery of the equipmen t or product during the warranty period. In this regard following conditions also may be noted:

- a) In case of failure of equipment or its components, breakdown call has to be attended within 48 hours of intimation.
- b) The defect should be rectified within two days after the call is atten ded, failing which replacement or standby equipment should be provi ded for uninterrupted services.
- c) In case of non-adherence to clause (a) or (b) above, downtime penal ty will be realised a sum equivalent either the repairing charges met by the Institute to set right the equipment or 0.1 percent per day of cost of the equipment, whichever is higher, from the date of report of breakdown by way of deductions from SD/Performance Bank Guarant ee.
- d) The time spent on the repair work will be added to the warranty peri od of the equipment

H. Payment Terms

100% payment will be paid after satisfactory installation and commissioning of equipment along with submission of "Installation Report" t o be issued by user department and DCE.

- I. Bidders should submit the Manufacturer's Authorization in attached format F (Buyer uploaded ATC Document).
- J. Delivery and installation of the item should be within 45 days from the date of issue of GeM Order.

BIDDERS SHOULD ALSO COMPLY THE ADDITIONAL SPECIFICATIONS

- 1. The ETO gas sterilizer should be fully automatic type for the sterilization of heat sensitive plastic items.
- 2. Technical data
 - a. Sterilization gas: Ethylene oxide 100%
 - b. Sterilization method: Cold sterilization of heat sensitive materials.
 - c. Operating temperature range: 37-55 deg Centigrade.
 - d. Number of doors: One

3. The sterilization chamber should be made up of suitable alloy which is resistant to corrosion and ETO ga s.

4. The chamber should be insulated against heat emission.

5. The construction of the chamber, door and all contact parts should be rust proof. It should be made up o f stainless steel of 316 grades or rust proof anodized aluminium.

6. The inner surface should be smoothly finished to minimize gas deposits.

7. The sterilizer door should have a quick release locking arrangement. The door locking should be autom atic. There should not be any handle at door to avoid tedious locking process. There should be provision fo r door push to lock the door and touch screen to unlock the door.

8. There should be safety interlocking arrangement for the door so that the sterilization process does not st art unless the door is properly locked in position and during the programme run, it should not open unless the residual gas has been completely eliminated from the chamber.

9. The sterilizer should have suitable mechanism to separate and evacuate residual gas from the chamber.

10. The sterilizer should have following cycle programmes

a. Sterilization cycle for heat sensitive objects that ensure temperature from 37^{0} C- 55^{0} C with subse quent aeration for protection of the operating personnel.

b. Aeration cycle / programmed to extract residual gas out of the sterilized objects after each steri lization cycle.

c. Automatic chamber evacuation cycle with subsequent venting before releasing the doorlock for opening, thereby prohibiting exposure of the operating personnel by gas dissolving from the chamber wall s during shut down period.

11. The sterilizer should have a minimum chamber capacity of 130 litres approximately.

12. Should be suitable for 2 carriage basket for sterilization load.

13. The ETO cartridge puncturing mechanism must be automatic and must not require any manual operati on during sterilization process.

14. Vaccum should be created only through ventury system using the available hospital central air system at 4 bar.

15. In case if the ETO cartridge does not puncture inside the ETO machine, then there should be an option for alarm and it should be displayed as "cartridge puncture failure".

16. One complete sterilization cycle should contain all the phases and it should be finished within 8-10 hou rs.All time-based parameters must be mentioned in printing.

17. Documentation – Thermal Printer / Dot-Matrix Printer Should Print Date, Batch/ Load Number, Program Type Elected and Program Parameters Which Includes One Point Pressure and One Point Temperature Print Out.

18. The temperature, pressure and status (along with all alarms) of the cycle must display on HMI screen d uring sterilization process. It should have minimum of 6" colour display touch screen for operation.

19. During sterilization cycle, the chamber pressure must maintain negative pressure. Negative Pressure C ycle (100% ETO Cartridge) indicative Cycle description:

- a) Vacuuming of chamber to set value
- b) Leak hold period
- c) Cartridge puncturing / gas purging depending on the cycle selected.
- d) Sterilization hold period for set time.
- e) Exhaust and aeration for number of aeration pulses set.

20. There should be reminder for ETO cartridge and fill water (RO water) before the start of cycle. 21. Ther e must be alarm in case of vacuum/air break could not be achieved in desired time and also for high tempe rature.

22. The touch screen should have features like audit trail, alarm logging and multiple passwords.

23. The ETO sterilizer should have compliance to IS/ISO 11135 and IS/ISO 14937 (ISO certificate produced by the equipment manufacturer shall be verifiable in international accreditation forum online database) in the absence of the aforesaid certificates US FDA approval certificate for the quoted model issued by US de partment of health and human services is acceptable.

24. The ETO sterilizer shall meet IEC 60601-1-2:2001(or equivalent BIS) General requirements of electric magnetic compatibility or should comply with 89/366/EEC; EMC directive.

25. The ETO sterilizer shall meet International Organization for Standardization. Biological evaluation of m edical devices. Part 7: ethylene oxide sterilization residuals [standard]. 1st ed. IS/ISO 10993- 7. 1995 (reaff irmed 2001). OR Any international/ National standard for ETO Safety.

26. Technical selection shall include the demonstration of the product at SCTIMST or at any of the nearby i nstallation location on request. Performance certificate from the competent authority of existing installatio n of the model quoted in operation for at least 3 years shall be submitted along with the bid.

27. The ETO sterilizer should have a valid Indian exposure monitoring certifications. If there is no Indian st andard available, then the quoted model shall have compliance to OSHA exposure monitoring.

28. The vendor should provide 100 numbers of ETO cartridges and Packaging Material with Chemical Indic ator of All Sizes: 10 rolls along with the sterilizer.

29. The vendor should disclose the list of consumables required for each cycle of sterilization process.

30. The vendor has to undertake the supply, installation, testing and commissioning of the ETO sterilizer.

31. The necessary civil, electrical, copper exhaust piping (approx. 20 meter) and plumbing works if requir ed for the installation of ETO machine has to be done by the vendor. The vendor may inspect the installation site prior to quoting the price.

32. All regulatory requirements for installing ETO sterilizers should be incorporated within the site; includin g the safe disposal of exhaust gas from the sterilizer as per existing regulatory norms.

33. All regulatory requirements (including the safe disposal of exhausted gas from the machine) for the saf e installation of ETO sterilizer should be incorporated within the site.

34. There should be an appropriate pollution control device (ETO Abator) for safe disposal of ethylene oxid e like catalytic converter or equivalent technology / gas disposal management to be as per local pollution control norms, if any (OPTIONAL). L1 will be calculated including optional items. But the price of optional it em should be mentioned separately in the price bid.
