Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM_No.1_4_2021_PPD_dated_18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

2. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc.

This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

Buyer Added Bid Specific Terms and Conditions/क्रेता द्वारा जोड़ी गई बिड की विशेष शर्तें

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Generic

Bidders shall quote only those products (Part of Service delivery) in the bid which are not obsolete in the market and has at least 7 years residual market life i.e. the offered product shall not be declared end-of-life by the OEM before this period.

4. Certificates

Bidder's offer is liable to be rejected if they don't upload any of the certificates / documents sought in the Bid document, ATC and Corrigendum if any.

5. **Generic**

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

6. **Buyer Added Bid Specific ATC**

Buyer Added text based ATC clauses

A. Bidders are advised to quote prices as per technical specification and additional specification.

B. Bidders should submit the Manufacturer's Authorization in attached format- A (Buyer uploaded ATC Document)

C. Liquidated Damages:

If the supplier fails to deliver or install/commission any or all the goods or fails to perform the services within the time frame(s) incorporated in the Purchase Order, the Purchaser shall, without prejudice to other rights and remedies available to the Purchaser under the contract, deduct from the contract price, as liquidated damages, a sum equivalent to 0.5% per week of delay or part thereof on delayed supply of goods, installation, commissioning and/or services until actual delivery or performance subject to a maximum of 10 % of the contract price. Once the maximum is reached Purchaser may consider termination of the contract.

If any delay by the supplier is maintained its contractual obligations towards delivery of goods and performance of services shall render the supplier liable to any or all of the following sanctions:

- a. Imposition of liquidated damages,
- b. Forfeiture of its Performance Security and
- c. Termination of the contract for default

D. SCTIMST reserves the right to ask for a free demonstration of the quoted equipment/ items after giving reasonable time to the bidder at a pre-determined place acceptable to the purchaser or at a site (in case of non-portable and heavy equipment) for evaluating the technical compatibility as per the bidding document specifications, professionalism and quality of work of the bidder for technically qualifying for opening the Price Bid. SCTIMST reserves the right to accept/ reject the bid based on the product/ site evaluation as stated above.

THE INDENT TITLE: A MOBILE APP FOR MEDICATION ADHERENCE AND RISK-FACTOR MONITORING OF STROKE SURVIVORS

THE PRIMARY REQUIREMENT OF THE APP DEVELOPERS ARE:-

1. TRIVANDRUM BASED SOFTWARE DEVELOPERS WITH PREVIOUS EXPERIENCE AS PROVIDERS OF WEB AND MOBILE TECHNOLOGY AND PRODUCT DEVELOPMENT.
2. WELL-ESTABLISHED REGISTERED COMPANY OF MORE THAN 8 YEARS OF EXPERIENCE IN APP DEVELOPMENT.
3. WITH AN AMBLE EXPERIENCE IN HEALTH-RELATED MOBILE APP DEVELOPMENT.
4. PREVIOUS EXPERIENCE IN DEVELOPING MOBILE APP FOR MEDICATION ADHERENCE AND RISK FACTOR MONITORING IN CHRONIC DISEASE CONDITIONS.

THE SPECIFICATION OF THE APP IS THE FOLLOWING: -

THIS PROJECT IS TO DEVELOP A MOBILE APPLICATION SPECIFICALLY DESIGNED TO MEET THE UNIQUE NEEDS OF STROKE SURVIVORS IN KERALA. THE APPLICATION AIMS TO ADDRESS THE FOLLOWING KEY OBJECTIVES:

1. **USER PROFILE MANAGEMENT:** THE MOBILE APPLICATION WILL FEATURE USER PROFILE MANAGEMENT CAPABILITIES, ALLOWING STROKE SURVIVORS AND DOCTORS TO CREATE AND MANAGE THEIR ACCOUNTS SECURELY. THIS INCLUDES LOGIN FUNCTIONALITY WITH PASSWORD MANAGEMENT FEATURES TO ENSURE DATA PRIVACY AND SECURITY.
2. **ENHANCE MEDICATION ADHERENCE:** DEVELOP FEATURES AND FUNCTIONALITIES WITHIN THE MOBILE APPLICATION TO FACILITATE AND ENCOURAGE MEDICATION ADHERENCE AMONG STROKE SURVIVORS BY PROVIDING TIMELY REMINDERS, TRACKING CAPABILITIES, AND EDUCATIONAL RESOURCES, CALENDAR UPDATES AND VIRTUAL CABINET OF MEDICINES. THE APPLICATION SHOULD EMPOWER USERS TO ADHERE TO THEIR PRESCRIBED MEDICATION REGIMENS EFFECTIVELY.
3. **FACILITATE RISK FACTOR MONITORING:** IMPLEMENT TOOLS AND MECHANISMS FOR MONITORING CRUCIAL HEALTH PARAMETERS SUCH AS BLOOD PRESSURE, BLOOD SUGAR LEVELS, AND BLOOD CHOLESTEROL LEVELS. THE APPLICATION WILL ENABLE USERS TO TRACK THESE METRICS REGULARLY, EMPOWERING THEM TO PROACTIVELY MANAGE THEIR HEALTH BY ASSIGNING THEM TO THE LOCAL PHYSICIAN, WHICH IS ALREADY PRESENT IN THE HEALTH SYSTEM AS PER THE NEEDS AND MITIGATE THE RISK OF RECURRENT STROKES.
4. **PROVIDE EDUCATIONAL RESOURCES:** CURATE AND DELIVER EDUCATIONAL CONTENT WITHIN THE MOBILE APPLICATION TO EDUCATE STROKE SURVIVORS ABOUT THEIR CONDITION, RISK FACTORS, TREATMENT OPTIONS, AND PREVENTIVE MEASURES.

8. **Generic**

Manufacturer Authorization: Wherever Authorised Distributors/service providers are submitting the bid, Authorisation Form /Certificate with OEM/Original Service Provider details such as name, designation, address, e-mail Id and Phone No. required to be furnished along with the bid

9. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.

2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
4. Creating BoQ bid for single item.
5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
7. Floating / creation of work contracts as Custom Bids in Services.
8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for [attached categories](#), trials are allowed as per approved procurement policy of the buyer nodal Ministries)
9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
11. Creating bid for items from irrelevant categories.
12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
13. Reference of conditions published on any external site or reference to external documents/clauses.
14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
